The appeal scheme involves the development of Tree Tent tourist accommodation within an ancient woodland. The appeal site is located partially within flood zone C2 and close to a number of historic assets. This site is sensitive in some respects, due to the presence of ancient woodland and a river running through the appeal site meaning there are potential ecology and flooding issues. However, whilst these matters will fall to be considered by the decision maker, I am satisfied that none of the potential impacts (either alone or in combination) would result in significant environmental effects, therefore EIA is not required in this instance.
