

NOTICE UNDER REGULATION 52(1) OF THE TOWN AND COUNTRY PLANNING

Development on land at Barry Biomass, Woodham Road, Barry Docks, Vale of Glamorgan, CF63 4JE

I give notice that Biomass UK No.2 Limited has lodged an appeal to the Welsh Ministers against an enforcement notice issued by The Vale of Glamorgan Council. The enforcement notice relates to operational development comprising the construction of a wood fired renewable energy plant together with associated structures and the material change of use from unused land having a nil use to the storage of containers and as a vehicle turning space in association with the use of the wood fired renewable energy plant.
