Proposed Advanced Anaerobic Digestion Plant.
Cog Moors Wastewater Treatment Works, Cardiff Road, Dinas Powys.

I refer to the application for full planning permission that we have submitted on behalf of Dwr Cymru Welsh Water for the change of use of land as an extension to the existing wastewater treatment works site and the construction of an Advanced Anaerobic Digestion (AAD) Plant, together with associated landscaping and mitigation measures and the formation of temporary construction compounds at Cog Moors Wastewater Treatment Works (Application Ref: 2017/01203/FUL).

As you are aware, following the submission of the above-mentioned planning application, a dormouse nest was found on part of the application site and, consequently, existing dormouse habitat would be lost as a result of the proposed development. In order to mitigate this potential loss, it is proposed to provide compensatory dormouse habitat on an area of grazing land situated on the northern side of Green Lane, subject to obtaining the necessary licence approval from Natural Resources Wales. This area of grazing land is outside of the current planning application site boundary and is in third party ownership.

In order to facilitate the provision of compensatory dormouse habitat as part of the current planning application, it is proposed to amend the planning application site boundary to include the above-mentioned area of grazing land on the northern side of Green Lane. The amended planning application site boundary is shown on Drawing Ref 4798-S-202-HYD-XX-XX-DR-XX-06101-S2-P02 (see enclosed disc).

It is also proposed to amend the description of the proposed development, in order to reflect the proposed provision of dormouse compensatory habitat as an integral part of the planning application. The following description of development is now proposed:

"Change of use of land as an extension to the existing wastewater treatment works site and to provide compensatory dormouse habitat and for the construction of an Advanced Anaerobic Digestion (AAD) Plant, together with associated landscaping and mitigation measures and the formation of a temporary construction compound at Cog Moors Wastewater Treatment Works (WwTW), Cardiff Road, Dinas Powys."


The revision to the planning application site boundary and the proposals for the provision of dormouse compensatory habitat necessitate consequential amendments to some of the plans and documents which currently form part of the submitted planning application. We are pleased to enclose a "Schedule of Changes" which indicates which of the previously submitted plans and documents remain unaltered and which are now superseded by amended versions. Copies of the amended plans and documents are included on the enclosed disc.

As indicated above, the proposed compensatory dormouse habitat land to the north of Green Lane is in third party ownership and is presently used for grazing purposes. We have, therefore, given the requisite notice to everyone who, on the day 21 days before the date of this amended application was the owner or agricultural tenant of any part of the land/building/agricultural holding to which the application relates. We enclose both a Certificate B and an Agricultural Holding Certificate duly completed (see enclosed disc).

We also attach a cheque to the sum of £190 in payment of the fee required in accordance with Regulation 5 of The Town and Country Planning (Fees for Applications, Deemed Applications and Site Visits) (Wales) (Amendment) Regulations 2016).
