

Due to marine environment the roller shutters need constant repair and servicing.


These shops are being used mostly in the summer periods with the funfair and the tourist attraction providing food or supplies for the beach activities.

1. ACCESS AND MOVEMENT

1.1 Site Location

The existing site location is shown in Photograph 1. The building is located by the sea front and can be accessed from the front and the rear pathways.

1.2 Inclusive Design

The proposed shutters are to match the existing shutters, the visual look will look the same and have the existing signage.

The proposed shutters will have the facility to allow ease of maintenance without disrupting or having to remove the existing signage. The replaced shutters will be on both sides which can be seen on illustration 1.

2. APPEARANCE AND CHARACTER

2.1 Layout

The proposed shutters will be located within the same opening that the existing shutters are, this can be seen on illustration 2.

2.2 Scale

There are 20 shutters to be fitted in total, 9 in the front, 9 in the rear and 2 on the sides. These can be seen in Illustration 1 and drawing AL (00) 02 provided.

The sizes of each shutter vary depending on the shop, this can be found on illustration 3.


