I refer to the enforcement case regarding the above-mentioned site. I have now had the opportunity to investigate this matter and inspected the site.

The alleged breach refers to the erection of a wooden structure on land adjoining 15 Spires Walk, Barry.

The works carried out at the property are development, but are considered to be 'permitted development' as defined by Class A, Schedule 2 of the Town and Country Planning (General Permitted Development) Order 1995.
