Pant Ruthin Fach Farm, St. Mary's Hill

Divert part of overhead network and replace with new overhead and underground sections, under the Electricity Act 1989

SITE AND CONTEXT

The application site is located at Pant Ruthin Fach Farm, St Marys Hill. The site is situated outside the settlement boundary, within open countryside.

CONSULTATIONS

This is a notification and there is no requirement for consultations.

REPORT

This OBS application relates to a notification by Western Power Distribution of their application under s37 of the Electricity Act 1989 (and for a direction under s90(2) of the Planning Act 1990 that Planning Permission be deemed to be granted) to divert part of the existing high voltage overhead network as the existing overhead line is affecting the business operation which exists at this location.

Western Power are required to divert part of the overhead network and replace it with partly underground and overhead sections around this area. The proposal is to divert 2 spans of high voltage overhead line away from the area of the business to avoid any potential issues. The existing design will be replaced partly by an underground section of high voltage cable and a new high voltage overhead span.

The application states that the works are covered within The Overhead Lines (Exemption) (England and Wales) Regulations 1990.

For information, s90(2) states as follows: -

90 *Development with government authorisation*

- (2) *On granting a consent under section 36 or 37 of the [1989 c. 29.] Electricity Act 1989 in respect of any operation or change of use that constitutes development, the Secretary of State may direct that planning permission for that development and any ancillary development shall be deemed to be granted, subject to such conditions (if any) as may be specified in the direction.*

The notification seeks any observations of the local planning authority and is essentially restricted to a consideration of whether the works would have a significant adverse effect on the environment, with a number of questions required to be answered as follows – and with the proposed responses provided below each.: -


