Hi lan, I hope that you are well.

Further to your email of last week, this is just a quick note to make you aware that we (Sol Environment) will be making a new set of applications to discharge the outstanding conditions associated with the extant '2015' Barry Biomass planning permission.

As discussed in our meeting, due to the fact that the NRW permit supersedes and overwrites the noise related conditions 21 and 25, we intend to make a separate and concurrent NMA application

to either change or remove these conditions accordingly. To avoid duplication we were thinking that the conditions 21 and 25 should be removed and replaced with a general condition that states the need to maintain compliance with all EPR permitted conditions relating to the agreed NRW Noise Management and Mitigation Plan.

We have by way of reference attached a copy of our updated Planning Conditions tracker. Please can you confirm that you are in general agreement of the outstanding conditions that need to be discharged before this planning application can be considered fully implemented and complied with.

On a separate note, I have been advised that timetable for the decommissioning of the Firewater Tank will be with you this week.
