As regards the Council's concerns over the 'backland' nature of the proposal, it was agreed that the suggested re-positioning of the dwelling towards the frontage of the site was an improvement. However, there were still concerns over the likely impact on the adjoining neighbour, particularly in relation to its overbearing nature. I can confirm that the later revisions received following the meeting reflect the possible changes discussed at the meeting, i.e. movement away from the boundary with the existing dwelling. A further concern over the revised scheme related to the design, in particular the lack of articulation on the front elevation. In accepting the case put forward at the meeting, i.e. that the proposed dwelling would be screened by the existing boundary wall to the garage compound, it was suggested that more detail be provided at first floor level. Note: Highways was also a concern but based on a number ideas, some guidance, time to reflect and input from neighbours we can now deliver a solution to ensure 2 cars can pass each off the highway. We aim to also reduce the cars in the cul de sac and can show how we intend to do this, which will benefit all residents.

After discussing with neighbours about the development, No 56 Heol-Y-Frehines confirmed they did not want us to pursue access via the garage compound. We do have an option to purchase a garage but overall the concern would remain the same in a sense that it would cause displacement of parking. We also have an opportunity to buy the whole garage compound, but again it has little relevance to access and does not provide us with anything more than what the new proposal provides. The new proposal stands alone and minimises the impact to current residents alongside delivering a solution that reduces cul de sac congestion and enables two cars to pass each other off the highway.
