**Subject**: RE: Planning issues with Incinerator

Dear Councillor Drake and Brooks,

I refer to your email and the attached photographs indicating the development at Woodham Road.

From viewing the photographs, it would appear that the tanks in the photos are the water tank and building being applied for as part of the planning permission 2017/01080/FUL, which has yet to be determined. The agent for the application has indicated that due to the time constraints and financial reasons the water tanks would need to commence despite formal planning consent not being determined at this time. It should be understood that as a planning application is currently with the Council for consideration, it is not within the remit of the planning enforcement team to take any action on the unauthorised work until the planning application has been formally determined. In the event that the application is approved, no further action would be necessary, however, if the application is refused, the enforcement team would have to consider what action would be appropriate to remedy the breach of planning control.

Accordingly, the construction of the tanks is being carried out at the developer's own risk and the Council's consideration of whether the buildings being constructed are acceptable or not would not alter whether the development is proposed or retrospective. As such, the risk is with the developer in this instance.

Notwithstanding the above, thank you for the email and we will take the representations into account when determining the current application.
