Hi Douglas,

I did speak with Matt but I am still having problems with the file he has sent. The Council has a A0 printer and a general printer that can print off A3. When I try to print this file off at actual size on the A3 printer then it will only print off a small portion of the file as the actual size sent to me is A1 (33.1 x 23.4in). So I have to make the file fit for an A3 and this is where the change to the scale is probably happening. However, I have tried to print off the file at A1 but for some reason the Adobe reader says the document cannot be printed.

I need to make you aware that while I was hopeful of the application going to the planning committee on the 11th Jan, along with the issues with the plans being correct, the Council is still awaiting a response from highways, the Chief fire officer and Public Health Wales and the deadline for the committee has passed. Public Health Wales only indicated to the Council that we to consult **Cardiff and Vale University Health Board** at the end of December while I was on leave. My line manager consulted the relevant contact while I was off but the 21 day period for them to respond would take it over the January committee. As such, at the earliest I will take the variation of condition application and any of the discharge of condition applications to the February committee on the 8th Feb. My deadline for that committee is 19th January, which would give these external bodies time to respond.

I understand that the application is taking a longer period of time but the Council are receiving a high number of representations and I am trying to ensure that there are no reasons why the application cannot be determined once it is seen by the planning committee. I attach an extension of time until just beyond the 8th February committee deadline.

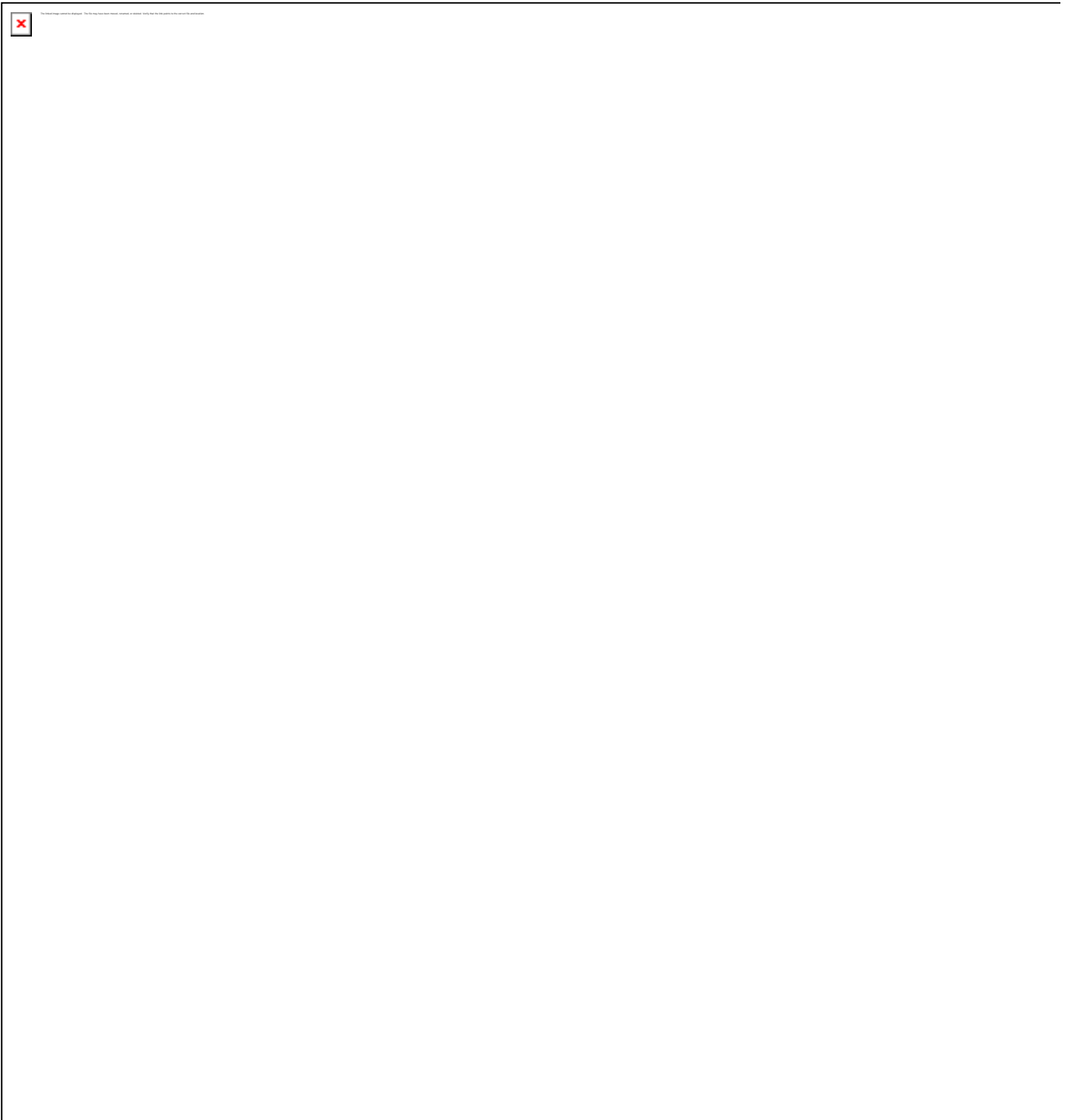

I have the drawing you sent to me printed off and if you check the dimensioned figures for visibility splays and set back from the road at 1:200 then it is not correct. The visibility splay length measures 46m (not 48m), the setback distance from the road measures 4.2m not 4.5 and the dimension set back stating 15m measures 14m. The scale and dimensions set out cannot be different as we approve the plan and this is what is agreed as part of the planning permission. I cannot rely on the scale if it is different to the dimensions.

The Highways officer and myself agree that the plan is not accurate so I am unsure why you think it is correct. You must understand that your application will be scrutinised by committee members and residents who are strongly opposed to this development and any inaccuracies will be highlighted.
