Morgan, I'm not aware of any % quantification - we just stuck to the industry classifications A to C throughout in the planning stage.

If the person making the enquiry wishes to provide an established definition with thresholds I'm sure we'd be happy to review it.

What I can share with you is that the feedstock supplier has to provide waste wood with, on average, a biomass content not less than 95% although we are actually targeting 97%.

The key thing in terms of percentages is what the waste wood becomes during the emissions stage and this is very strictly regulated by Natural Resources Wales.

I hope this helps.

Thanks Morgan – the updated drainage details are in hand and should be with you before too long.

As to the query concerning waste wood, the position is unchanged from that explained during the consultation period in respect of 2015/00031/OUT: only non-hazardous grades A, B & C (Industry Standards) will be processed at the plant.

Contaminants are therefore of the type and quantity falling within these grades and the feedstock supplier for the project is obliged to ensure the feedstock complies with the planning consent and meets such specifications.

Emissions are of course separately regulated by the Environment Agency via the environmental permit.

I trust the answers your question and could I ask you to provide us with copies of all correspondence with DIAG on this matter under the Environmental Information Regulations when convenient.
