Hi Morgan: I have now received various inputs in response to Faye Tomalin's outstanding questions, as below:

1. Sprinkler System Capacity

The drawing that should be referred to is Barry_01_DWG_01_20145_D (see attached).

The capacity of the system has been designed to accommodate the volume from a storm return period of 1:100 years with an allowance for 20% increase for climate change or the volume of a 1:1 year storm with an allowance for 20% increase for climate change + fire demand. This means:

1. The 1:100 year event provides a required attenuation volume of 485m³. The level of water in the tank at this condition is identified in Section A-A.

- 2. The fire condition provides a required attenuation volume of 709m³. This volume is derived as the box note on drawing BARRY_01_DWG_01_20145_D, from a 1:1 year storm of 120m³ + sprinkler demand within the reception building of 369m³ and an allowance for 220m³ from fire appliances.
- 3. The total attenuation volume provided within the tank is 652.8m³ which is more than adequate for the 1:100 year storm (point 1 above). An additional 54m³ is provided within the reception building which provides the required attenuation for condition 2 (652.8+54 = 706m³).

Note that the box at the top right hand corner of the previous iteration of this drawing had an error in that it referred to 120m3 relating to 1:100 year storm. This was obviously an error as it should refer to 1:1 year storm but the volume is correct. I have had the designers correct this and the amended drawing (Barry_01_DWG_01_20145_D) is attached for completeness.

Therefore in summary there is capacity for 1:100 storm plus 30% and a 1:1 year storm plus all requirements for sprinklers and fire water.

2. Discharge of Water

Concerning the ABP drainage system final discharge point for the site, as explained in the revised Condition 13 Discharge submission dated 7 March 2018, the discharge point can be seen on "Plan BARRY_DWG_01_DWG_01_20134_E surface water drainage" which was previously provided to you. I attach this plan again for convenience.

Discussing this with the project engineer who previously spoke with Faye Tomalin, he believes her main concern relates to the interaction between the drainage and the fire prevention strategy. A Fire Prevention Plan (FPP) has been approved by Natural Resources Wales as part of the permit application following extensive consultation in respect of which the Vale of Glamorgan Council was a statutory consultee. It is assumed that relevant departments within Vale of Glamorgan Council will have reviewed the FPP as part of such consultation.

Within the FPP it has been stated that in the event of a fire, all firewater from the fire and sprinkler system will drain into the surface water drainage system which will discharge to the underground attenuation storage tank. The discharge pumps will be interlocked to ensure that all firewater remains contained within the attenuation storage tank (the pumps that empty the attenuation tank to the docks are isolated to prevent them from operating).

All potentially contaminated firewater will then be contained within the attenuation storage tank and tankered off-site for disposal in compliance with applicable environmental requirements. If the attenuation storage tank is nearing capacity, the Operator will arrange for a tanker service to come and remove the water within the tank.

For the avoidance of doubt, no contaminated water as a result of a fire will be discharged into the dock.

I trust this now deals with all remaining questions on this application.

Hi Morgan,

At this stage we still have objections to the discharge of conditions on this site.

The applicant is stating that the attenuation tank on the site is sized for the 1 in 100 yr +20% for climate change, plus an allowance for the fire protection sprinkler systems. No information has been provided on the capacity allowed for the sprinkler system, and how this compares to the volume of storage required for the 1 in 100 yr + 30% event.

Further information is required on the ABP drainage system final discharge point of the site. Should this be into the docks, there are concerns that there may be a detrimental effect on water quality, particularly if water from the sprinkler system is to enter the surface water network. Should this be the case, further information on water quality treatment phases are required, and NRW should be consulted on this part of the application.
