STEP ONE: Risk assessment 'walk about'

Length of route What is the route?	Along St Andrews Rd as far as the junction with Twyncyn. Turn left into Twyncyn, and then onto the 'private dive' at the top of Twyncyn until it reaches the entrance to The Spinney. The reverse route will operate in the afternoon.

Do you think the traffic is breaking speed limits or not slowing down enough on the route, e.g. on bends or where there are parked cars?	No
Are the children separated from traffic in any way? (e.g. railings, or a wide verge of grass) (This isn't compulsory, but helps us understand the safety of your route)	No
Bowling Club Car Park - safety	Parents arrive from 9.40am and park herringbone style in the Bowls Club Car Park. Upon arrival pupils will be collected in a safe area on the right hand side, inaccessible to cars. There will be no vehicular movement within the car park until the pupils are segregated in the designated 'safe'

Have you identified any particular hazards on the route that means a child could be hit by a vehicle while on the Giant Walking Bus?	<ol> <li>Pedestrians should use a pavement and where possible avoid being next to the kerb with their back to the traffic. If they have to step into the road, look both ways first. Always show due care and consideration for others.</li> <li>Large groups of people walking together should use a pavement if available; if one is not, they should keep to the left. Look-outs should be positioned at the front and back of the group, and they should wear fluorescent clothes in daylight and reflective clothes in the dark. At night, the look-out in front should show a white light and the one at the back a red light. People on the outside of large groups should also carry lights and wear reflective clothing</li> </ol>

Hazard  Large groups of people walking together	*Help other road users to see you. Wear or carry something light-coloured, bright or fluorescent in poor daylight conditions. When it is dark, use reflective materials (e.g. armbands, sashes, waistcoats, jackets, footwear), which can be seen by drivers using headlights up to three times as far away as non-reflective materials.  *When taking children out, keep between them and the traffic. *Pedestrians should use a pavement and where possible avoid being next to the kerb with their back to the traffic. If they have to step into the road, look both ways first. Always show due care and consideration for others.  *Large groups of people walking together should use a pavement if available; if one is not, they should keep to the left. Look-outs should be positioned at the front and back of the group, and they should wear fluorescent clothes in daylight and reflective clothes in the dark. At night, the look-out in front should show a white light and the one at the back a red light. *People on the outside of large groups should also carry lights and wear reflective clothing.  *Ensure the correct ratio of adults to children - 1:10.  *Ensure Disclosure & Barring requirements are adhered to.  *Have mobile phones and contact numbers readily available in the event of an emergency.
Private drive	The 40m narrow stretch of private drive will require the 'driver' to act as a 'lookout' before the walking bus proceeds safely.
'Social Danger' is subjective. In this context the commonest interpretations provided by children and young people are as follows: stranger danger; danger(s) posed by paedophiles, criminals (muggers, thieves, murderers, kidnappers); anti social behaviour (presence of bullies, alcoholics, drug addicts on walk to school); and physical manifestations	Pupils are accompanied on the route by two adults – one to he for and one to the rear. The children will be visible and in close proximity to at least one adult at all times. The school will ensure the safety of the children at all times. Liaison with VoG Council in all such matters in order to be aware of risks.  During the walk the pupils will be in close contact with each other and their teachers; they will not engage in conversation with strangers

such as discarded needles or places where drug abuse/misuse take place.	
LIGHTING The level of natural lighting will differ over the year. Seasonal change may require that a review of the route assessment may be appropriate	Street lighting on St Andrews Road and one side only on Twyncyn.  Torches recommended for use by pedestrians: -during Autumn & Winter months Supervisors to have white light to front and red light to rear of walking groups
