- Secure site boundary fencing, minimum 1.8m high. Weld mesh anti-climb fence, to SbD standards e.g. Dulok double wire mesh fencing at 1830mm height, powder coated in black colour. With matching gates. Supplier by CLD Fencing.
 - Secondary secure fencing to playground zones. Weld mesh anti-climb fence, e.g. Dulok double wire mesh fencing at 1430mm height, powder coated in black colour. With matching gates. Supplier by CLD Fencing.
 - Fencing to refuse store and substation. Timber hit and miss fencing, with metal support posts. Minimum 2400mm high. With matching gates. Roof not included. Supplier to be approved.
 - Retaining walls

 - Handrail. Pro Railing System by FH Brundle, subject to final design by manufacturer. In stainless steel 316, height to BS.
