the report is assuming only 22% of vehicles

taken into account, but does not explain how,			
thus casting doubt that it is been sufficiently			
accounted for.			
4) The report makes no mention of the traffic			
impact from the Scholar's Park housing			
development in Dinas Powys will have on the			
Merrie Harrier junction (Cardiff Road/B4267/			
A4055 and A4055/B4267/Andrew Road			
junctions). This additional traffic would not be			
present when the traffic counts were
