Further to my email below we've now had a chance to consider NRW's attached response to the above application. I note that NRW are querying the following:

- i) whether surveys been done of trees that are proposed to be removed to assess their likely use by bats and
- ii) whether the Aston Lagonda sub-station building been surveyed for roosting bats.

In response to this I can advise that all the trees along the route were surveyed particularly those highlighted for removal, none of which were deemed suitable for bats. Likewise, the Aston Martin Lagonda (AML) substation was also looked at and deemed to have negligible potential for bats. Accordingly, please see attached a revised Ecological Appraisal which provides further clarification on these matters.

NRW have also requested that the Wildlife Protection Plan be amended to ensure that if any GCN are found the measures to be followed will ensure no risk of an offence and I therefore attach an amended document.
