Thank you for consulting us about this application; consequently we have reviewed the detailed information contained on your website.

The information in the Historic Environment Record curated by this Trust indicates that note the proposal is located in an area of very high archaeological potential with highly significant prehistoric and Roman remains in the vicinity, as well as a lime kiln and two potential ring ditches.

However, the area was utilised as a site compound/storage area during the construction phase of the Five Mile Lane road scheme. Furthermore, the current proposal only relates to landscaping works which will result in the existing ground profile being raised by a maximum of 300mm. Therefore it is unlikely that significant archaeological remains will be encountered during the course of the proposal.

As a result, there is unlikely to be an archaeological restraint to this proposed development and consequently, as the archaeological advisors to your Members, we have no objections to the positive determination of this application. The record is not definitive, however, and features may be disturbed during the course of the work. In this event, please contact this division of the Trust.
