Proposal : Proposed replacement primary school including additional nursery provision and associated works Location : St. Nicholas Church In Wales Primary School, St. Nicholas

Thank you for the attached letter inviting comments on the proposed replacement school at St Nicholas Church in Wales School.

As set out in the Town and Country Planning (Development Management Procedure) (Wales) Order 2012, Sport Wales is the statutory consultee on developments affecting playing fields. The above proposal involves the loss of approximately a third of the playing field area, which includes what appears to be a mini pitch, and therefore we would like comment as follows.

Reference is made to the relevant policy in Planning Policy Wales which states that "All playing fields whether owned by public, private or voluntary organisations, should be protected from development except where:

- facilities can best be retained and enhanced through the redevelopment of a small part of the site;
- alternative provision of equivalent community benefit is made available locally, avoiding any temporary loss of provision; or
- there is an excess of such provision in the area."

In assessing the case against the above policy, the first exception does not apply as approximately a third of the playing field cannot be considered a small part and a mini pitch will be lost. The second exception does not apply either as there is no mention of alternative provision being made available.

The supporting Design and Access Statement does however refer to the Council's Open Space Background Paper (2013) which indicates that St Nicholas has an overprovision of outdoor sport facilities of 1.89 ha therefore suggesting there is excess of such provision in the area. Sport Wales is not aware of any other playing fields in the village and would query what land has been counted towards that figure?

Also, with regard to the specific needs of the school, Sport Wales makes reference to the Schools Premises Regulations which sets out minimum team game playing field areas for schools dependent on the number of pupils. Will the reduced playing field area meet the statutory minimum for the increased number of pupils at the school?

Until further evidence can be provided addressing Planning Policy Wales and the Schools Premises Regulations, Sport Wales would like to object to the application.
