Thank you for consulting us about this application; consequently we have reviewed the detailed information contained on your website and can confirm that **the proposal has an archaeological mitigation**.

Information in the regional Historic Environment Record, curated by this Trust, shows that the application area is located at the recorded site of the Supermarine Spitfire N3221 crash, however, the information file on the asset indicates that the Spitfire broke up in the air over Bonvilston (on the 6th February 1943), with the wreckage recorded in fields below Pendoylan. As a result, it is unlikely that there will be associated remains within the proposed site. The application area is also located adjacent to the A48, which at this point follows the line of the Roman road from Cardiff to Neath. It is also located in proximity to the medieval core of Bonvilston. As a result, there is the potential for associated archaeological remains to be located in the area, and so be adversely affected by the proposals.

It is our recommendation that a condition requiring the applicant to submit a detailed written scheme of investigation for a programme of archaeological work to protect the archaeological resource should be attached to any consent granted by your Members.

We envisage that this programme of work would take the form of a watching brief during the groundworks required for the development, with detailed contingency arrangements including the provision of sufficient time and resources to ensure that any archaeological features or finds that are located are properly investigated and recorded; it should include provision for any sampling that may prove necessary, post-excavation recording and assessment and reporting and possible publication of the results. To ensure adherence to the recommendations we recommend that the condition should be worded in a manner similar to model condition 24 given in Welsh Government Circular 016/2014

No development shall take place until the applicant, or their agents or successors in title, has secured agreement for a written scheme of historic environment mitigation which has been submitted by the applicant and approved by the local planning authority. Thereafter, the programme of work will be fully carried out in accordance with the requirements and standards of the written scheme.
