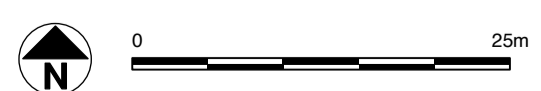

- 2 **PONY SEESAW** - SUITABLE FOR 1.5-4 YEARS BY PLAYDALE REF. SPR19 OR SIMILAR APPROVED
- 3 **TIMBER SNAKE SWING** - SUITABLE FOR 6-12 YEARS BY PLAYDALE REF. SSK7/5 OR SIMILAR APPROVED
- 4 **INCLUSIVE ORBIT ROUNDABOUT** - SUITABLE FOR 3-14 YEARS BY PLAYDALE REF. IORB OR SIMILAR APPROVED
- 5 **NEW WAVE LIFE PLAY TOWER** - SUITABLE FOR 3-12 YEARS BY PLAYDALE REF. OJBNEW OR SIMILAR APPROVED
